### **FEA 2023 Annual Conference**

More than 215 members attended the 2023 FEA Annual Conference in Santa Fe, New Mexico, Sept. 19-21.

Those in attendance heard from more than 16 general-session speakers on topics such as ethics, thorny 1031 exchange issues and complicated reverse exchanges.

FEA extends sincere thanks to our 24 conference sponsors.

Sponsors met with conference attendees throughout the week to discuss the business-related services they provide for QIs and like-kind exchanges.

In addition to the general sessions, FEA members also participated in the organization's annual meeting of members at the conference luncheon on Wednesday, Sept. 20. At the meeting, members ratified the slate of new board members and approved a change to the FEA bylaws aimed at allowing the FEA 1031 PAC to reach employees of member companies who wish to support the FEA PAC, but are obligated under another PAC. Under the change, individual members of FEA will now be able to vote for one seat on the FEA board of directors. The change will take effect in 2024.

FEA also hosted a new member orientation for new members and first-time attendees. At the event, participants heard from FEA board members and committee chairs about the various benefits of FEA membership.

FEA's 2024 annual conference will take place in Austin, Texas, Sept. 16-18. We look forward to seeing you in Texas!

FEA recognized the following leaders at the 2023 annual conference:




### 2023 FEA President's Award: Lynn Harkin, Amplify
